With over 150 members, the Network continues to grow, offering training, technical assistance, consulting, educational resources, and connections to ensure that communities have the tools they need to build and operate these complex real estate projects.

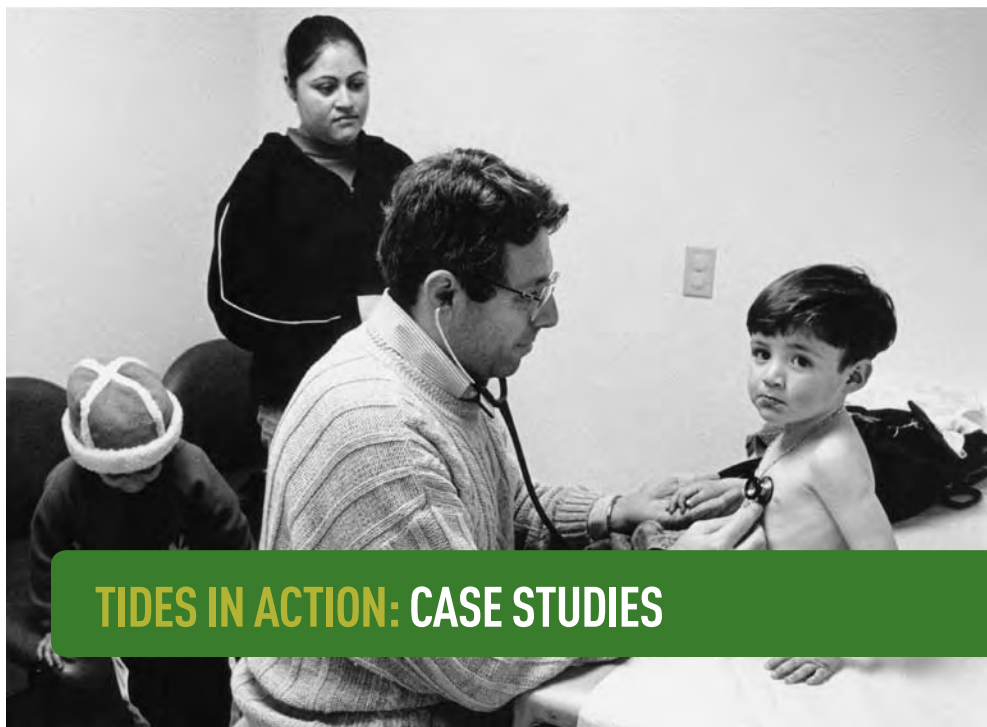

A UNIQUE COLLABORATION, A STATEWIDE COMMUNITY COMMUNITY CLINICS INITIATIVE

In February of 1999, The California Endowment turned to Tides to start a \$10 million campaign to help community clinics upgrade their computer systems. Eight years later, the ensuing project has awarded more than \$80 million to clinics in all of California's 58 counties.

The Community Clinics Initiative (CCI) has been a groundbreaking partnership between Tides and The California Endowment. Led by clinicians on the front lines of today's healthcare crisis, CCI is focused on improving health care for Californians living in the most underserved communities.

Housed as a Tides Center project, making grants through Tides Foundation, and maintaining office space at Tides Shared Spaces Thoreau Center, The Community Clinics Initiative has grown from a good idea into a robust and effective program that has enabled doctors to get information faster, create more efficient appointment and billing systems, and collect data that can be used in critical policy debates.

The California Endowment has made only four grants to Tides, from which Tides has awarded 527 grants to clinics throughout the state—reaching 91% of the nearly 200 nonprofit clinics and their associations in California.

CCI has also created a statewide community through numerous convenings organized by Tides staff and through the Community Clinics Voice—an online community of over 1,000 people who work with community health centers.



A CRITICAL NEED, A GROWING MOVEMENT

THE CATALYST FUND

Women of color in the United States face disproportionately high reproductive health challenges. Yet women of color-led organizations are consistently underfunded, despite a track record of success.

In 2007, Women of Color Working Group of the Funders Network on Population, Reproductive Health and Rights came to Tides to launch The Catalyst Fund to address this problem. The Ford Foundation and Public Welfare Foundation provided seed funding, and Tides Foundation has provided a home and staffing for the project.

Tides conducted extensive field research to ensure that the Catalyst Fund's program aligned with the interest and capacity of local funding institutions to support this important work. As a result, we identified eight local funding partners from across the nation—from Chicago to New Mexico, from New York to Hawaii. The Catalyst Fund will provide matching grants to these local funding partners, who will in turn make grants to local women of color-led organizations.

Through a technical assistance program, The Catalyst Fund also provides its local partners fundraising and strategic communications training and tools to support their efforts to raise new money and raise the visibility of women of color-led reproductive justice work. The project will also track and evaluate the impact of its grantmaking through a formal assessment program—all with an eye toward sustaining effective groups.

Connect US seeks to advance a vision for responsible U.S. global engagement in an increasingly interdependent world. Supported by a donors' collaborative and managed by Tides, Connect US is a community of individuals, initiatives, and organizations working on foreign policy issues. Founded in 2003, five funding partners now play a key role—the Charles Stewart Mott Foundation, Ford Foundation, Open Society Institute, Rockefeller Brothers Fund, and the William and Flora Hewlett Foundation.

The Connect US community shares the conviction that the United States must address critical global issues—such as climate change, nuclear proliferation, poverty, and regional stability—by working closely and with the support of friends, allies, and other major stakeholders in the international community in a responsible manner.

Tides provides the grantmaking and administrative infrastructure for the program staff of Connect US. The direct grant program supports initiatives looking to impact policy debates and to help create an effective network between advocates with a common global mission. Through the convening of stakeholders, its website and newsletter, and other means, Connect US serves as a source of information on critical policy issues and on the activities of grantees and other advocates. The project also seeks to help foreign policy advocates meet policy goals through the application of network-centric strategies—harnessing advancements in communication technology, new thinking in resource mobilization, and best practices in collaborative initiatives to help participants coordinate, prioritize, and collaborate on U.S. foreign policy reform.
