## **COMMUNITY POWER & CLIMATE JUSTICE**

Thank you to our generous inaugural donors who supported us in launching the Frontline Justice Fund at Tides Foundation this year. Because of you, we initiated our first grantmaking cycle in spring 2022 and elevated the leadership and vision of 10 community-based organizations across the US and Puerto Rico with grants totaling \$625K.

Practicing participatory grantmaking principles, in January we welcomed a new Independent Advisory Committee comprised of frontline environmental justice leaders and funders who lead the development of the fund's strategy and make recommendations for grantmaking.

Throughout 2022 we continued to build a strong strategic and operational framework for growing support to frontline climate justice groups engaged in litigation or regulatory actions at the local, state, or regional level. And in October, we hired our first program officer, Kimberly Middleton, to manage our climate justice initiatives, including the Frontline Justice Fund.

Our second cycle of grantmaking in December will disburse \$3.63M to grassroots organizations across the US and Puerto Rico and will be our first commitment to multiyear support — 62% of the total number of grants will be two-year commitments.

What makes the Frontline Justice Fund (FJF) unique among climate justice pooled funds is a laser focus on supporting frontline groups who are actively engaged in or anticipate engaging in legal or regulatory actions on an environmental justice issue that is critical for the health and safety of the community. They may have excellent pro bono or paid legal representation, but that alone doesn't guarantee success. What they require is additional support and capacity to mount a holistic and successful campaign. That's where FJF comes in. We hope you'll join our continued efforts in 2023.

#### WHO WE ARE

The Frontline Justice Fund is a Tides Foundation pooled grantmaking initiative launched in 2022 focused directly on supporting frontline community groups who are fighting for environmental and climate justice through legal advocacy. FJF bolsters these groups by ensuring they have the resources they need to succeed and thrive beyond the courtroom.

Using a participatory grantmaking model and governed by an Independent Advisory Committee (IAC) of environmental justice leaders, FJF acknowledges the personal risk and financial toll of prolonged legal battles undertaken by community groups fighting entrenched perpetrators of the climate crisis. The Frontline Justice Fund is designed to protect, repair, and prepare communities to confront environmental and climate legal battles in the short and long term by providing access to rapid response or multiyear funding to cover non-legal costs associated with mounting and sustaining successful legal advocacy campaigns.



Frontline communities have been organizing across the line, both on the inside and on the outside, using a meta strategy that involves not only fighting the bad but building the new.

# **FUNDING PRIORITIES**

**Legal Action.** Funding groups engaged in, or anticipate engaging in, protracted legal or regulatory actions to advance environmental and climate justice.

**BIPOC Communities.** Focusing on groups representing Black, Indigenous, and people of color (BIPOC) and/or represent low-income frontline communities most impacted by environmental harm, racism, and injustice.

#### FUNDING PRIORITIES, continued

**Frontline Communities.** Lifting up communities where resources will have a direct impact on the frontlines. These are communities most impacted by environmental harms, with broader implications in the fight for environmental and climate justice.

**Non-legal Costs**. Funding those who require rapid response or multiyear funding to cover non-legal costs with mounting and sustaining successful legal or regulatory advocacy campaigns (i.e., organizing, communications, technical expertise, capacity building, etc.).

Using these priorities as our guideposts, the fall 2022 grantmaking round included two additional criteria given the current legal, policy, and regulatory landscape:

**/ Geographic focus:** Prioritize funding in chronically underfunded regions, especially the Southeast, Gulf South/TX, and Appalachia/Ohio River Valley. Nearly 70% of funding will be allocated in these regions.

/ Issue focus: While FJF remains committed to funding across a broad range of environmental justice issues, this round prioritized support to groups that are engaged in (or anticipate engaging in) legal or regulatory actions designed to fight existing or proposed extractive industry infrastructure projects that threaten the health, safety, and well-being of frontline communities.


#### 2022 GRANTMAKING BY THE NUMBERS



### **OUR APPROACH**

- / Flexible, unrestricted general operating and project support grants to contribute to the sustainability of frontline environmental and climate justice organizations.
- / Provide rapid-response grants to cover urgent legal battles and multiyear grants on a case-by-case basis to help groups thrive for the long term.
- / Funding decisions through a participatory grantmaking model designed to work directly in partnership with frontline groups, leaders, and activists.
- / Trust-based philanthropy practices that are accessible, transparent, and responsive. The FJF seeks to apply the 6 Practices of Trust-Based Grantmaking to address the inherent power imbalances between funders and grant recipients.
- / Partner closely with national and regional environmental litigation groups to ensure that grantmaking is aligned with larger legal campaigns and strategies.
- / Draw upon Tides' 45 years of experience working hand-in-hand with movement leaders and grassroots environmental and social justice organizations.


